### Describe what type of impact the mentioned FLW generates


In socio-economic impact, consider how FLW affects income and livelihoods of producers and other value chain actors (transporters, aggregators, intermediaries, wholesalers, consumers, etc.).

In food and nutrition security consider the volumes of produce that are lost before reaching the consumer.

In environmental impact consider the land, water, and energy that was used to produce the product that are lost and associated green house gases.
